- Wave roses (Direction vs. H_s and vs. T_p) for all measured data
- Incidence of storm waves for 2010 and for all previous years. Storm events are defined using the Peaks-over-Threshold method. The highest H_s of each storm event is shown.
- Annual time series of H_s (red line is storm threshold)

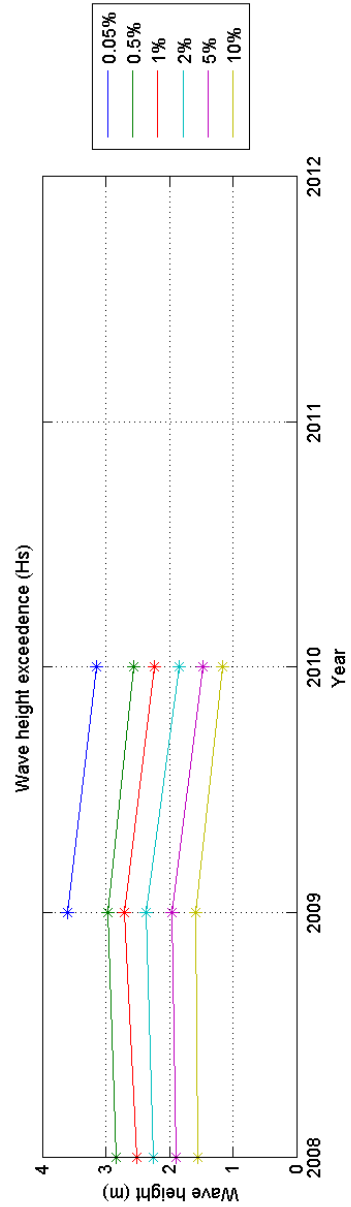
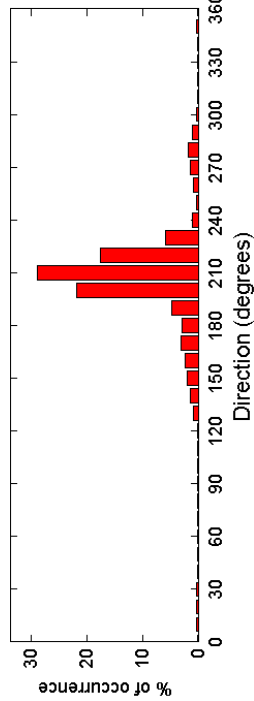
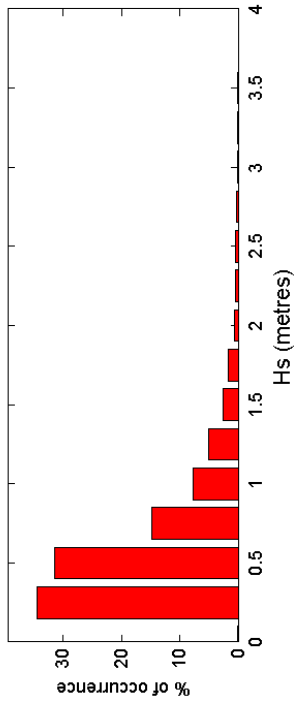
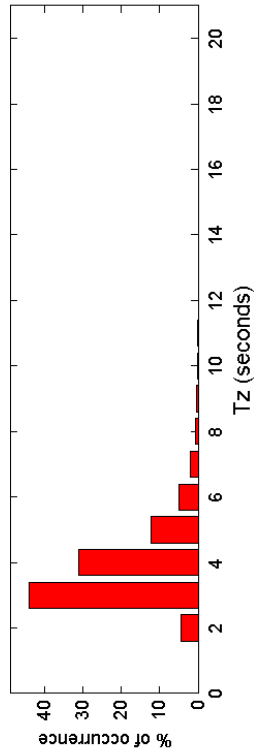
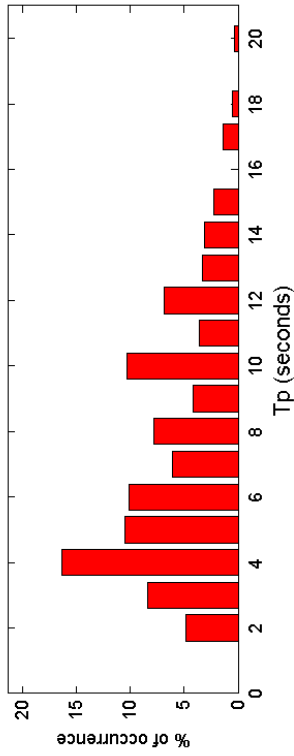
General

The buoy, owned by Environment Agency (Southern Region), was first deployed on 22 August 2008.

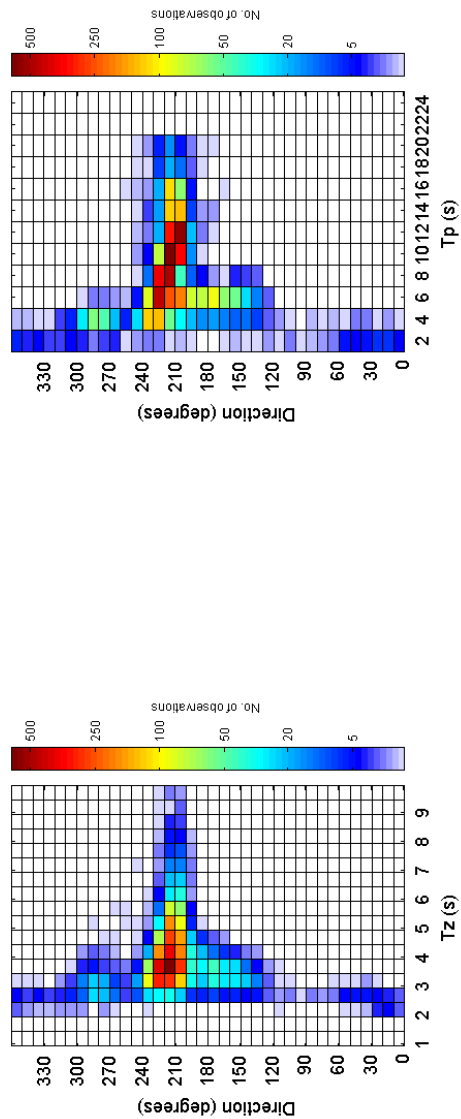
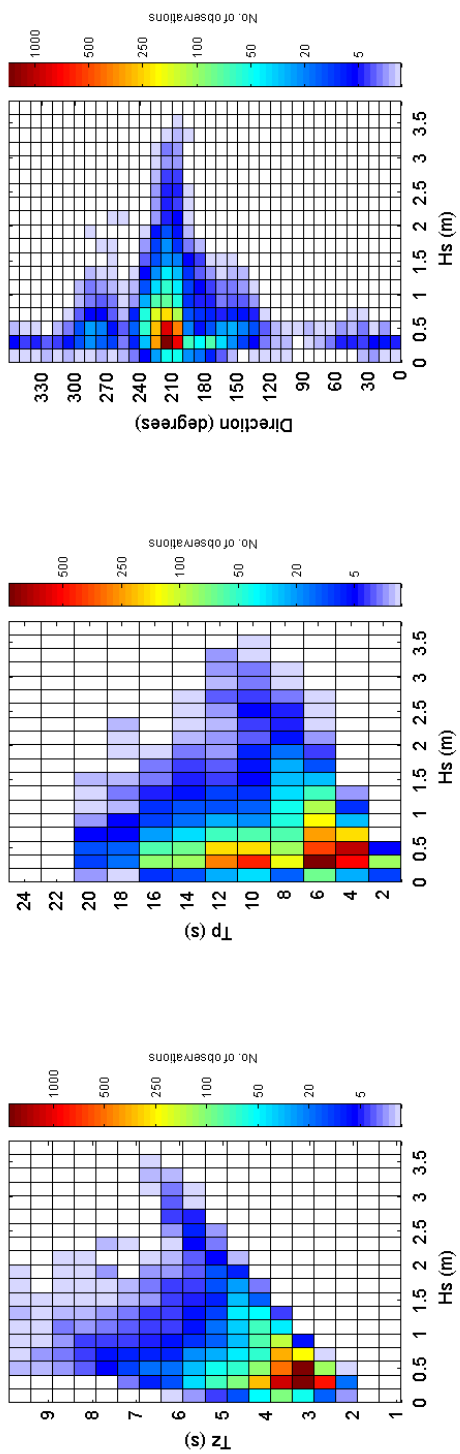
Acknowledgements

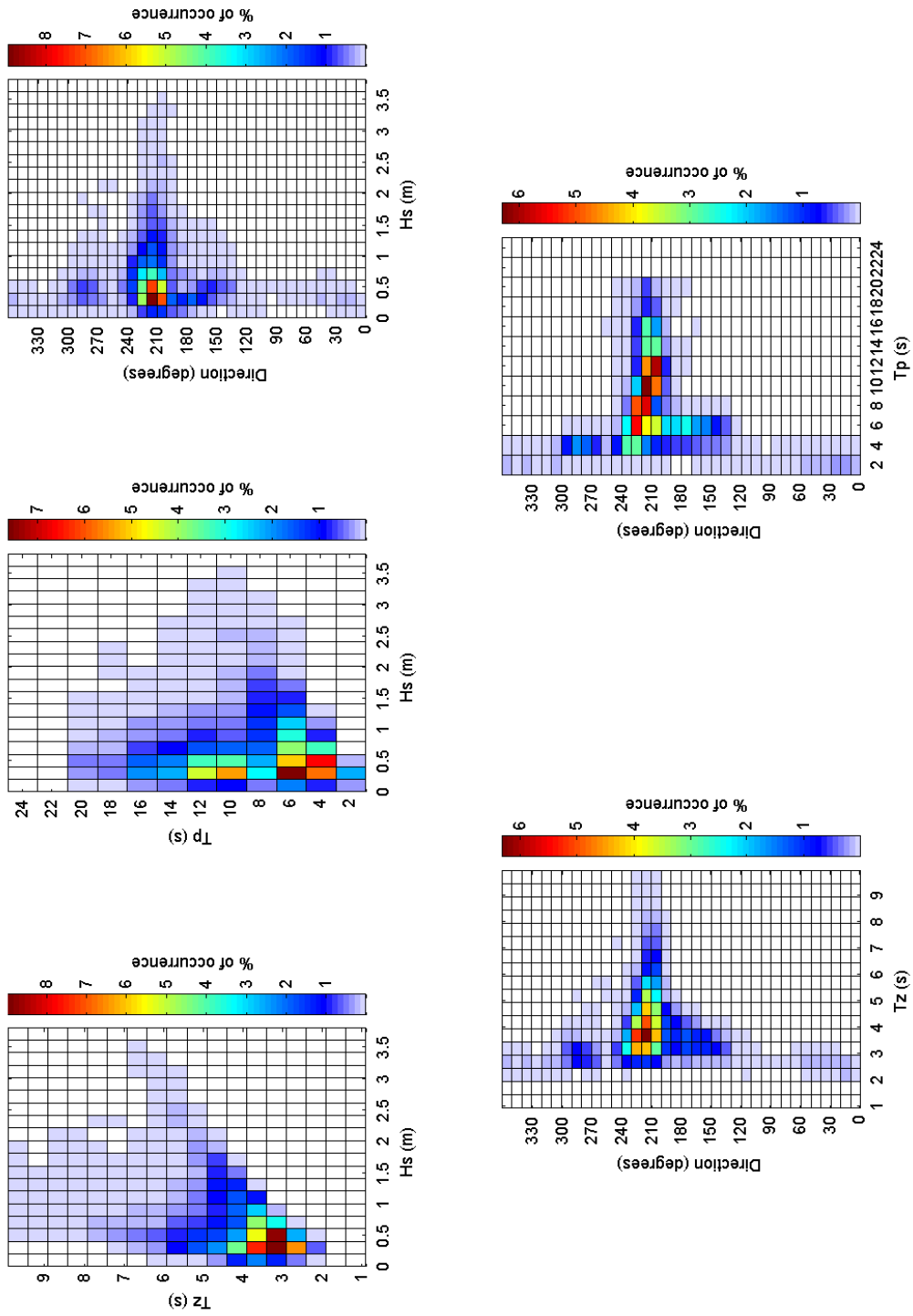

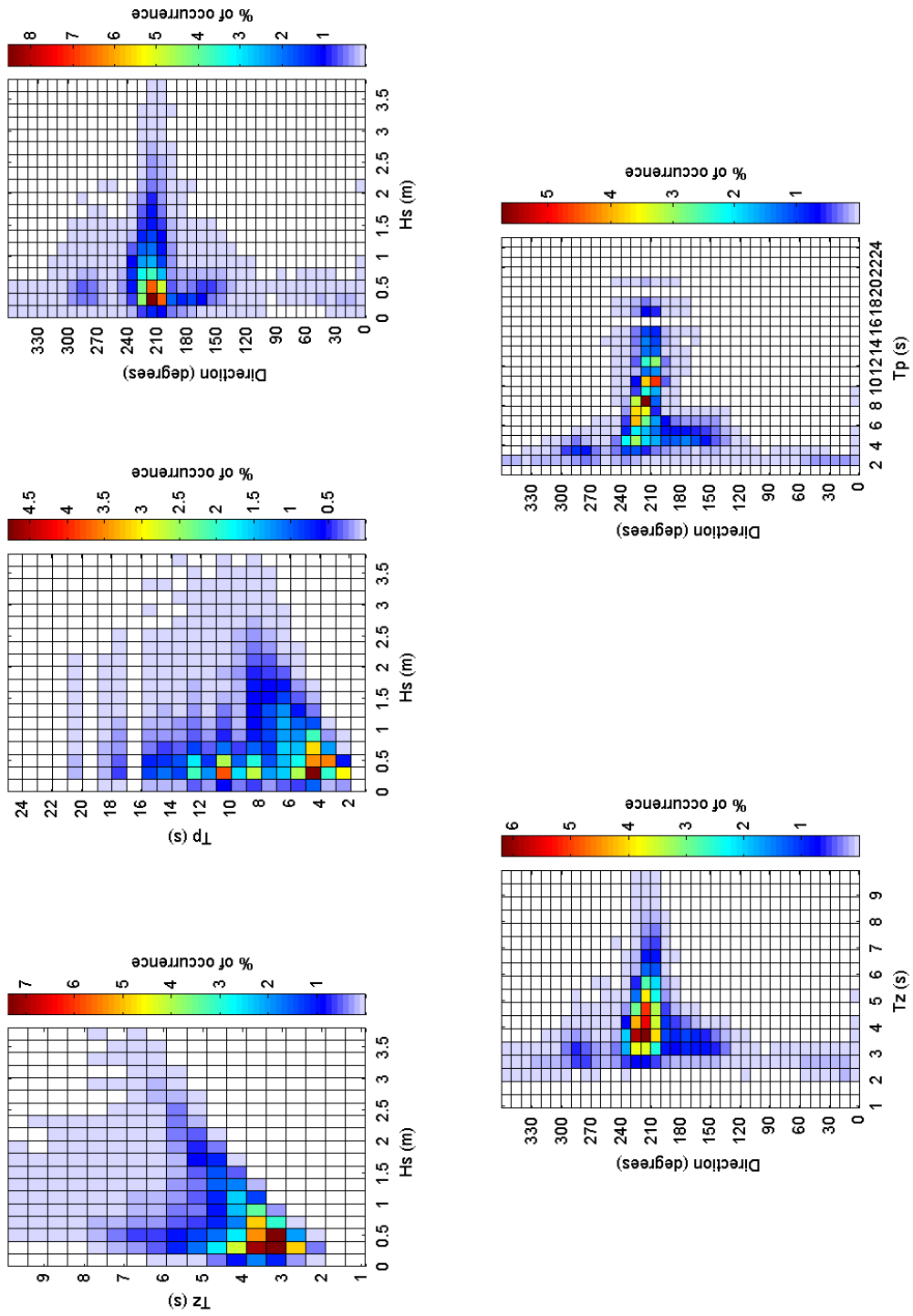
Bracklesham Bay 2010 - Joint distribution

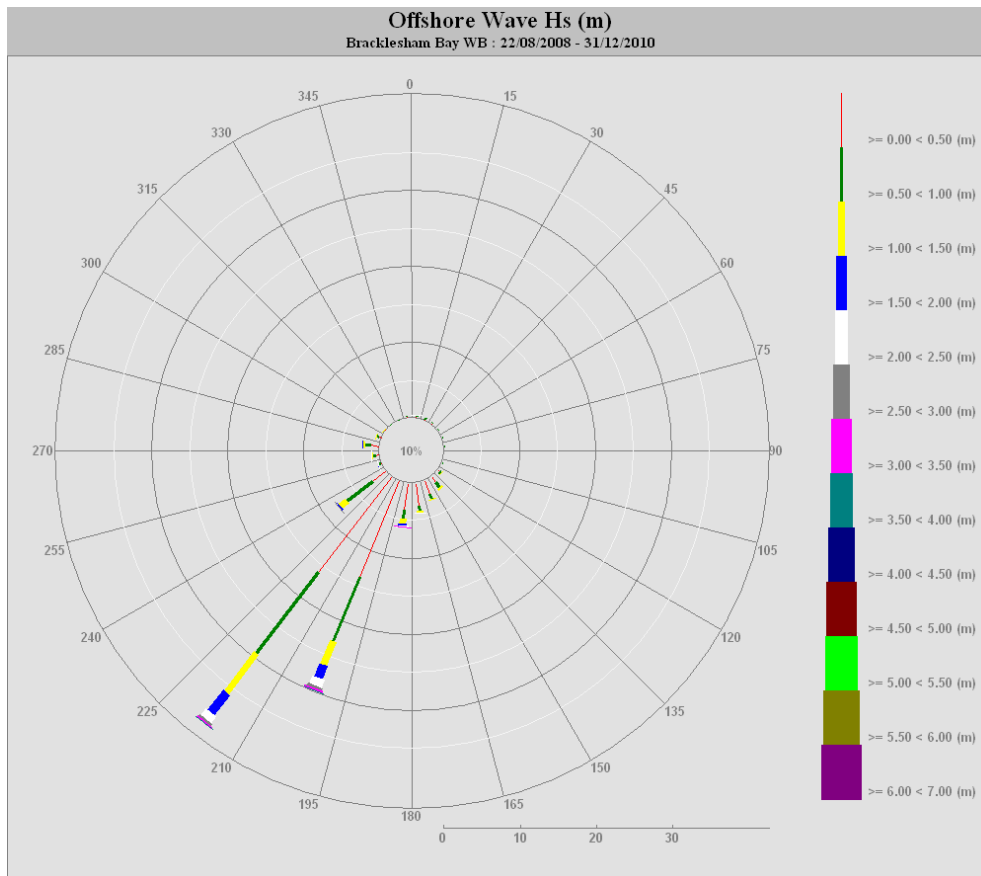


Bracklesham Bay 2010 - Joint distribution (% of occurrence)

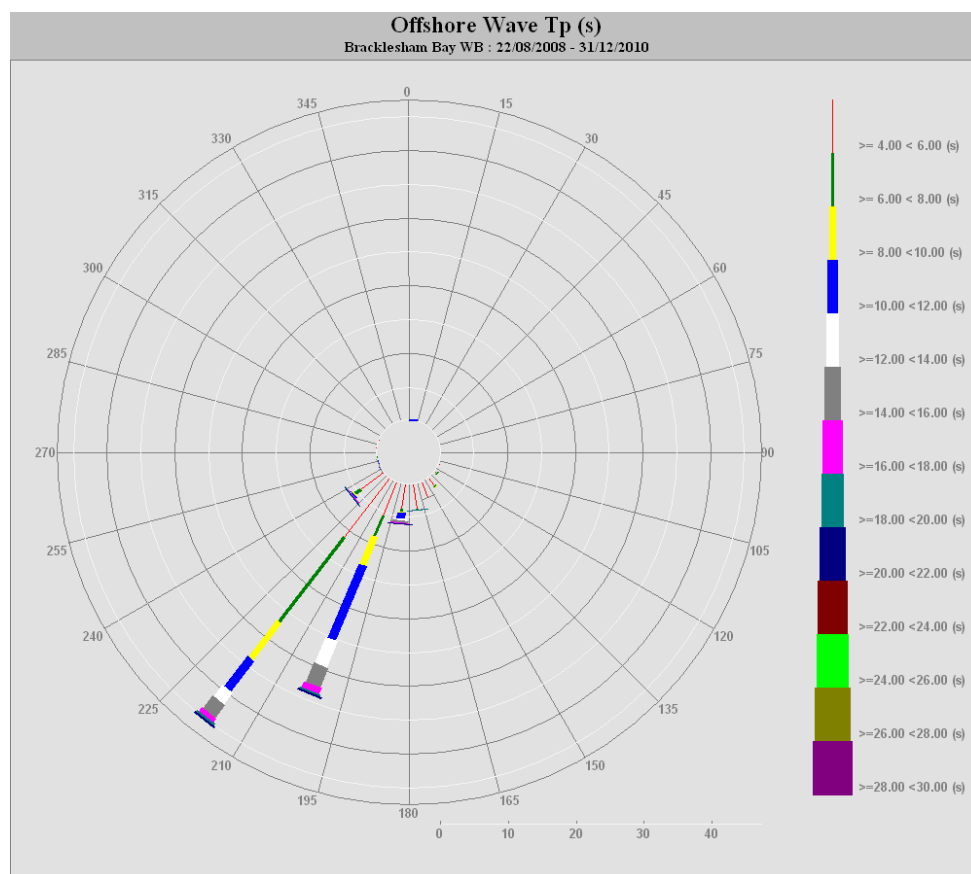


Bracklesham Bay 2008 to 2010 - Joint distribution (% of occurrence)
